

# International Student Guide: Post Graduate Work Permit Application

This application is made online.

You must apply for the PGWP within 180 days of receiving your letter of completion—you don't need to wait for your diploma/certificate or for convocation.

You must have valid status in Canada at the time of application.

You must ensure your study permit is valid until at least the completion date of your program.

New for all applications with the original study permit made after November 1, 2024:

To be eligible for a post-graduation work permit (PGWP), you must meet all eligibility requirements.

#### General eligibility

You meet the general eligibility requirement to apply for a PGWP if

- you completed a study program at <u>a designated learning institution</u>
- you maintained full-time status as a student in Canada during each semester of your study program (exception for final term)
- you apply for your PGWP within 180 days after you graduate
- your study permit was valid at some point during the 180 days after you graduate

#### Eligibility based on study program

As a graduate of a college program, you must <u>prove your English or French language skills</u> by taking one of the language tests approved by IRCC (English tests are CELPIP, IELTS and PTE Core. Click the link above for more information). Your test results can be no more than 2 years old.

#### Eligibility based on field of study:

If your study program has a <u>field of study requirement</u>, you must graduate from a program linked to certain occupations in long-term shortage. The fields of study are divided into 5 broad categories:

- agriculture and agri-food
- health care
- science, technology, engineering and mathematics (STEM)
- trade
- transport

#### **Getting your Documents from NSCC:**

- After you have submitted all your course work or work placement documents at the end of your program, your faculty will put a final grade in for each of your courses or a P for pass for your work placement.



- The Assistant Registrar at your campus will confirm you have completed the requirements for your program.
- You will then get your letter of completion emailed to your personal email.
- Once you receive your letter of completion, you can request your final transcripts using this form.

# Submitting the application:

#### Processing time can vary.

You may be required to submit biometrics for this application if you have not done so already in a previous application. If you need to provide biometrics, IRCC will notify you after you submit your application online. There is a fee of \$85 for this process

#### You may have to provide results from a medical exam performed in the last 12 months, if:

- Your work will be in a job where public health must be protected
- You lived in a "designated country" for 6 months in a row within the last year

#### **Start your application:**

#### Log into your IRCC account through GCKey or Sign-in partner:

#### 1. Complete the questionnaire

Scroll down to "Start an Application" and choose "Apply to come to Canada". You should not have a personal reference code at this time, so scroll down to "I do not have a Personal Reference Code", and click on:

#### Visitor, study and/or work permit

Answer the questions. Some will be based on your personal situation and are not included below. However, some answers are mandatory to access the correct application. Please use the guide for these:

#### **Extra Information**

**Section A** – if you answered "yes" to having a medical exam within the 12 months, upload an eMedical Information Sheet or call IRCC Help Centre to obtain your UMI#. The toll free number is 1-888-242-2100.

Then, create a Word document with the following information:

date and country where the exam was conducted and the UMI# given by IRCC.

Your online application will prompt you to submit this confirmation of medical examination.

**Section B** – If you have lived in certain countries, or you intend to work in certain jobs, you may be required to undergo a medical exam – these jobs include any work that brings you in close contact with others (working with children, in healthcare services or labs) or agricultural work. 

When you complete the questionnaire, you will then see a list of required documents to upload.



PLEASE NOTE – as of November 4, 2024, the checklist does not show "Proof of Language Proficiency". You must upload the language scores under "Client Information" until the site is updated

If you have any additional information about your specific situation that you feel will support your application, or that you want a visa officer to consider, you can write this in a document and upload under "Optional Documents – *Client Information*". Otherwise, you don't need to provide anything in this section.

It is advised that you wait for your PGWP to be processed and approved before renewing your TRV.

### **Gather the following supporting documents:**

- digital photo (420x540 pixels)
- a scanned copy of your passport (include all pages with stamps, visas, photos)
- a letter from NSCC stating that you have completed your program
- a copy of your transcript (official or unofficial)
- proof of language proficiency (official language test scores)
- any other documents generated in your online list

Pay the fee online: \$255



#### **Working while you wait**

After submitting online, you can work full-time while you wait for a decision if you meet this criteria:

- Your study permit was valid at the time of your submission
- You were enrolled full time in a degree or diploma program that was longer than eight months
- You did not work over the authorized number of hours per week when you were a student

# You are not authorized to work after completing your studies if you have not submitted your PGWP application.

If your application for your PGWP is denied, your legal status will end. If you are employed, you must stop working immediately, and you will be asked to leave Canada. You may be able to apply to restore your status as a visitor, depending on your situation.

#### Travel after submitting an application for PGWP

You can travel after submitting your application online. However, please note the following:

- You must have a valid TRV or eTA to re-enter Canada
- The border officer may ask you for proof that you applied for a post-graduation work permit (a copy of your application, the fee payment receipt, etc.)

When you return to Canada:

- You may enter as a student if your study permit is still valid
- If IRCC approved your PGWP while you were away, you may enter as a worker
- If your PGWP is still in process, you may enter as a visitor, and you can work without a work permit until a decision is made (if you met the criteria to do so)

# **Open Work Permit for Spouses of PGWP holders**

As of January 21, 2025, eligibility requirements for open work permits for spouses are as follows:

Family OWPs are limited to **spouses** of foreign workers who are employed in

- TEER 0 or 1 occupations, or
- select TEER 2 or 3 occupations in sectors with labour shortages or linked to government priorities
  - select high-skilled occupations in TEER 2
  - o <u>select high-skilled occupations in TEER 3</u>

The PGWP holder must also have at least **16 months** remaining on their work permit at the time when their spouse applies for the OWP.

Dependent children of foreign workers are not eligible to apply for an open work permit under your PGWP.



OWPs that were approved under the previous measures and have not expired will remain valid.
