## International Student Guide: Renew your Study Permit

You must renew your study permit if your permit expires before you complete your program of study at NSCC. Please make sure you apply for your study and co-op work permit renewal **before** the current permits expire to continue your study and work placements.

Visit <u>Temporary residents: Maintained status during processing (previously called implied status)</u>

You don't need a **Provincial Attestation Letter (PAL)** when renewing your study permit if you've entered Canada and you're applying for a study permit extension at the same Designated Learning Institution (DLI) and level of study as your current study permit. For more information, please visit the <u>IRCC website</u>, or ask your Student Services Advisor – International Supports.

### **Please note the following:**

- *If your passport will expire soon*, apply for a new passport **before** applying for your study permit.
- If you intend to work in Canada after you graduate, you will need a valid study permit when you apply for your post-graduate work permit (PGWP). Ensure you have 3 extra months after your studies officially end.
- You may be required to submit biometrics for this application, if you have not done so already in a previous application. There is a fee of \$85 for this process, and instructions will be provided.

### If you plan to travel:

Ensure you have a valid travel visa that will allow you to enter Canada if you need to leave and return. Your study permit is NOT a travel document. You must have a valid visa that allows you to enter Canada. <u>You can see more about travel documentation here</u>. Be sure to get the travel visa when you are in Canada, as processing times may be longer outside Canada.

# If you are renewing your study permit because you are changing institutions, you must include:

- A letter explaining why you're changing schools
- Documents that prove that you meet the criteria below and if you believe you meet the criteria to begin studying at the new DLI while your new application is in progress



- You stayed in Canada since you received your letter of acceptance (LOA) from the new DLI **and**,
- You continue to meet the conditions of your previous study permit **and**,
- Before you completed your course or program of study, you find yourself in one of the following situations with the previous DLI:
  - *it closed*
  - *it discontinued the course or program of study*
  - o it was placed on the suspension list or
  - *it lost its designated status*

# If you are renewing your study permit because you are moving from high school or language school to NSCC:

- You need to get a new study permit by <u>applying to extend</u> your current study permit to attend a post-secondary school. You also need a Provincial Attestation Letter (PAL).
- **Important:** If you graduate from high school early, your study permit will no longer be valid 90 days after you graduate, regardless of the expiration date on your study permit.

### If you are PAL-exempt (you are not changing schools):

• You need to upload a PAL exemption letter, which you must write yourself. **You do not need a PAL exemption letter from the college.** 

A template letter is included at the end of this guide. Personalize this letter with your own information, and in the document checklist.

### Follow these steps to apply to renew your study permit online:

#### 1. Create/Login to your IRCC account

. Your Client ID (8- or 11-digit number from your study permit) is required to complete the registration. DO NOT use your passport number to register.

### **Complete the questionnaire**

Scroll down to "Start an Application" and choose "Apply to come to Canada". You should not have a personal reference code at this time, so scroll down to "I do not have a Personal Reference Code", and click on:
