

International Student Guide: Working On- and Off-Campus & Applying for a Social Insurance Number

If you are a full-time student, you do not need a work permit to work on- or off-campus, but you will need a Social Insurance Number (SIN).

Use IRCC's <u>self-assessment tool</u> to see if you are eligible to work off campus without a work permit.

To qualify, you must:

- have a valid study permit,
- be a full-time student,
- be enrolled in a diploma or certificate program at NSCC that is longer than 6 months.

*Your study permit **must** include this condition on the document – if it doesn't, contact your International Student Advisor for assistance in requesting an amendment:

• May accept employment on or off campus if meeting eligibility criteria as per R186(f), (v) or (w). Must cease working if no longer meeting these criteria

If your study permit doesn't have work conditions on it

You can ask to have these conditions added if you're <u>eligible to work off campus</u>. There's no fee to add these conditions to your permit.

You must <u>request an amendment to your study permit</u> before you can apply to Service Canada for a SIN.

Working on-campus

You may work on campus at the institution where you study without a work permit if:

- you have a valid study permit
- you are enrolled as a full-time student at NSCC
- your study permit has the condition authorizing on-campus work

Working off-campus

You may work off campus while completing your studies. International students may:

• work up to 20 hours per week during regular academic sessions and

 work full-time during scheduled breaks between terms, such as the winter and summer holidays or spring break – you must be enrolled full-time in the next available term to work on a scheduled break

Co-op Work Experience and Working Off-campus

During your work experience, you are still enrolled as a full-time student, so technically you are authorized by IRCC to work part-time. You can work both your full-time co-op work experience and a separate part-time job at the same time.

Part-time Study and Work

If you are enrolled part-time you cannot work on- or off-campus, unless you are in your **final semester of study**. In this term, if you are enrolled part-time, you can still work off campus under your study permit.

Applying for a Social Insurance Number

The **Social Insurance Number** (SIN) is a nine-digit number that you need to work in Canada or to have access to government programs and benefits.

You need to provide a primary document to apply for a Social Insurance Number (SIN). Please see http://www.servicecanada.qc.ca/eng/sin/apply/proof.shtml for complete information.

A primary document is an official document that proves your identity and status in Canada. Service Canada needs to see an **original** of your primary document. If the name on this document is different from the name you currently use, you will also need to provide a supporting document.

All documents **must** be written in **English or French** or be accompanied by an official translation attested to by the translator before a notary public, or prepared by an officer of a foreign government or an official of the British or Canadian Consulate.

Primary and supporting documents for students

Generally, your primary document is a **study permit** issued by IRCC. A study permit is acceptable only when it indicates that the permit holder "may accept employment" or "may work" in Canada. **If neither of these statements is on the study permit, you will need to apply to amend your study permit through IRCC.**

Important note for temporary residents: you will receive a temporary confirmation of SIN letter that begins with the number "9". Your SIN expires on the date indicated in the "expires on" field of the letter. This expiry date is based on the IRCC document that authorizes you to work in Canada.
